Consent form for the use of images and recording

Dear Parent/Carer,

During the course of the school year, we may sometimes wish to take photographs or video recordings of children within school or on school trips, either for our own records for use as part of our learning curriculum, or for inclusion in our promotional material such as the school prospectus and our website.

The school also invites an external photographer to school each year to take official school photographs and may invite the media in to take photographs of pupils engaged in school activities or events for publication.

To comply with the General Data Protection Regulation, we need to ask your consent before the school record any images of your child. In view of this, please read the statements below, complete the slip and return this form to school as soon as possible.

The following statements set out the various reasons for taking and making use of images of your child and we should be grateful if you would indicate whether or not you give consent for use in these circumstances.

We will not use the personal details or full names of any child in a photograph or video on our website or in any printed publications.

Photographs by parents or other family members are not to be taken during school events such as school plays, sports day etc.

Please do not share any images or recordings provided to you by the school. We should all be aware of particular circumstances that may exist for certain children who may have protection in place because of safeguarding/child protection rulings.
